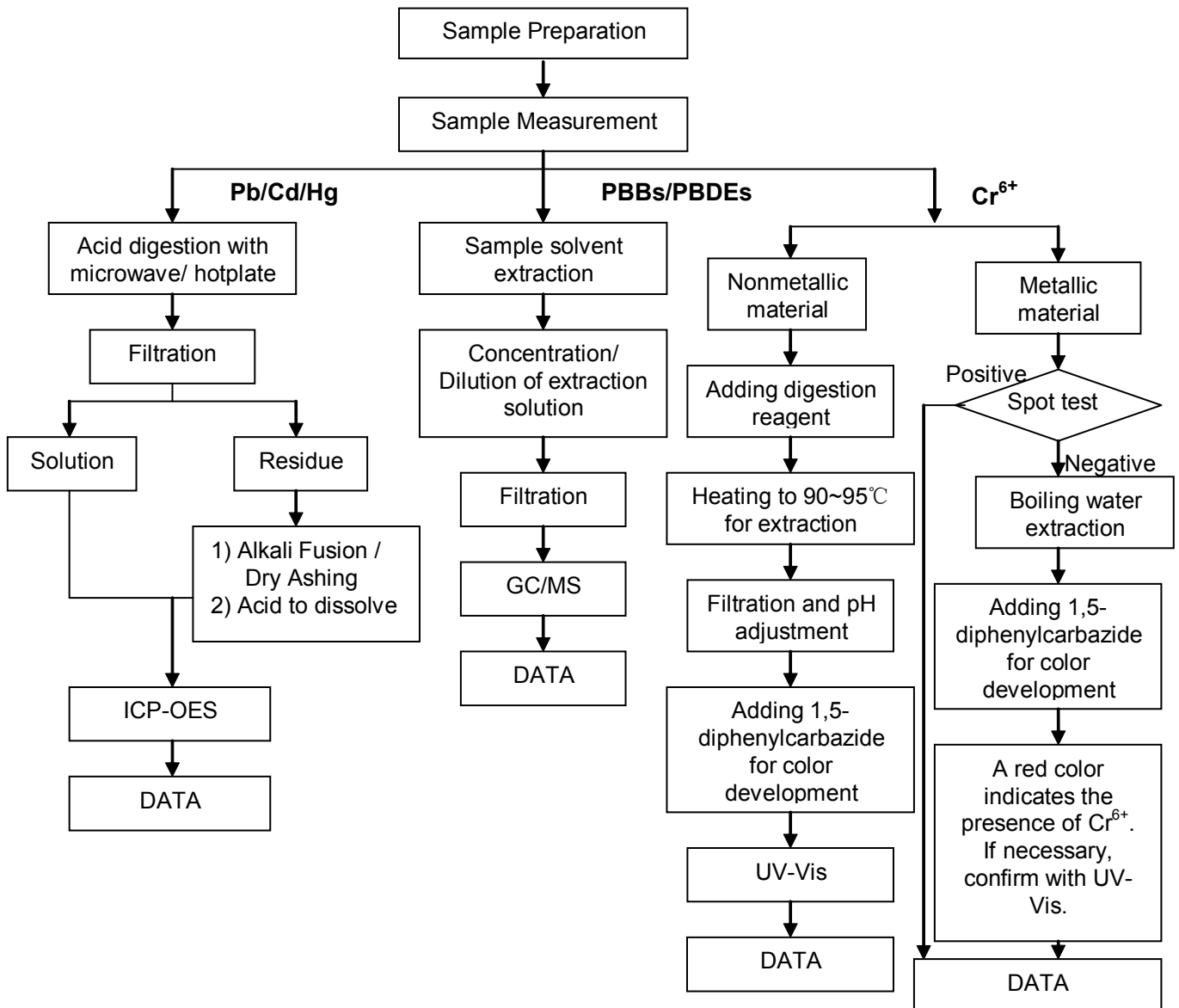

RoHS Testing Flow Chart

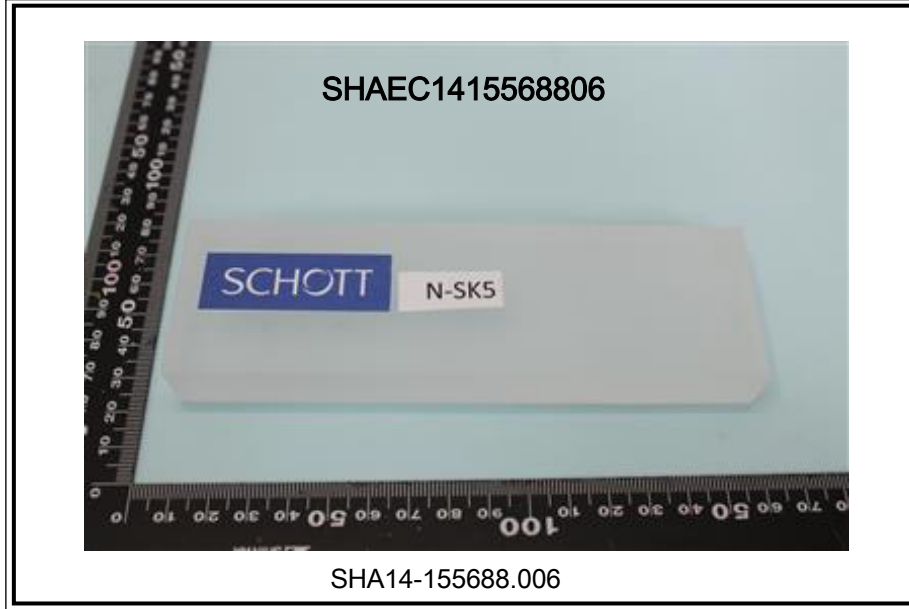
